#### **Definitions**

A motorcycle operator is the person in control of the motorcycle.

Passenger is any person seated on the motorcycle but not in control of the motorcycle.

**Motorcyclist(s)** refers to any combined reference to the motorcycle operator as well as the passenger. **Injury** includes incapacitating injury and non-incapacitating injury.

**KAB** – "K" represents fatalities; "A" represents incapacitating injury; and "B" represents non-incapacitating injury.

#### **Inclusions & Exclusions**

Data includes single motorcycle crashes from 2007 – 2009 with a fatality or injury. Crashes involving other vehicles, trains, pedestrians, non-contact vehicle or bicyclists are excluded.

- 24.6% of motorcycle-only KAB crashes occurred on Friday
- 61.8% of motorcycle-only KAB crashes occurred in daylight and 20.4% occurred in the dark in an unlighted area
- 51.5% of motorcycle-only KAB crashes occurred in areas not built-up and 26.0% occurred in a business locale
- 63.0% of motorcycle-only KAB crashes occurred in clear weather and 33.3% occurred in cloudy weather
- 2.6% of motorcycle-only KAB crashes occurred in a work zone
- 53.1% of motorcycle-only KAB crashes occurred between 12:00 Noon and 7:59 p.m.
- 54.7% of motorcycle-only KAB crashes occurred between May and August
- 29.1% of motorcycle-only KAB crashes occurred on city streets and 20.8% occurred on county roads
- 14.3% of motorcycle-only KAB crashes occurred in an intersection
- Unsafe speed (42.5%) was the primary contributing factor in motorcycle-only KAB crashes
  - o 20.5% were unsafe speed on curve/turn
  - o 7.8% were exceeding the legal speed limit
- 60.7% of motorcycle-only KAB crashes occurred on straight roads
- 69.7% of motorcycle-only KAB crashes occurred on level roads
- 93.6% of motorcycle-only KAB crashes occurred on dry roads
- 78.0% of motorcycle-only KAB crashes occurred on roads with an asphalt surface
- 66.0% of motorcycle-only KAB crashes occurred on two-way not divided trafficways
- Point of first contact on motorcycles in motorcycle-only KAB crashes
  - o 26.9% front of motorcycle (clock position 12)
  - o 21.4% mid-section of left side of motorcycle (clock position 9)
  - o 18.0% mid-section of right side of motorcycle (clock position 3)
- What motorcycle did in motorcycle-only KAB crashes
  - o 30.3% departed roadway (right)
  - 24.9% went straight ahead
  - 15.4% departed roadway (left)
- 86.0% of the motorcycles in motorcycle-only KAB crashes were occupied by the operator only
- 17.5% of the motorcycle operators in motorcycle-only KAB crashes had an alcohol-related driver condition
- 93.5% of the motorcycle operators in motorcycle-only KAB crashes were male
- 61.1% of motorcyclists killed in motorcycle-only KAB crashes were not wearing a helmet
- 51.6% of motorcyclists injured in motorcycle-only KAB crashes were not wearing a helmet
